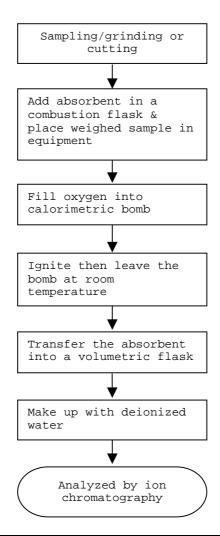

Test for Halogen Content Reference Standard: EN 14582



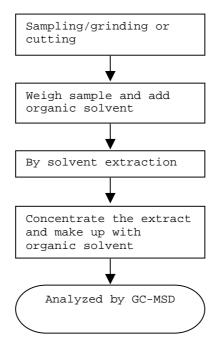

Test For Phthalates Contents Reference Method: EN 14372: 2004



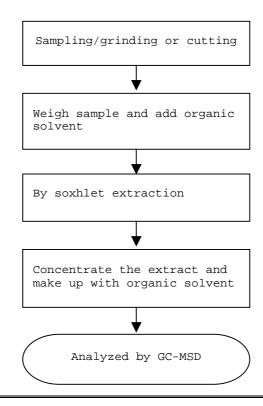

Test For Phthalates Contents Reference Method: EN 14372: 2004



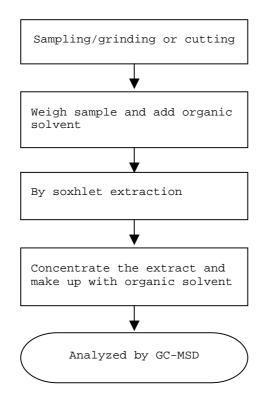

Test for Halogen Content Reference Standard: EN 14582

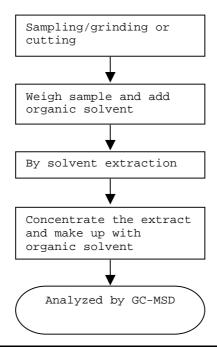

Test For Phthalates Contents Reference Method: EN 14372: 2004



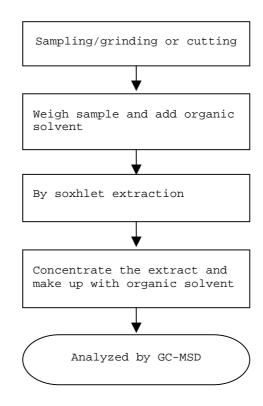

Test For Phthalates Contents Reference Method: EN 14372: 2004



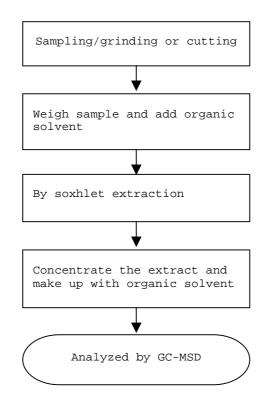
