2. Test for Hg Content

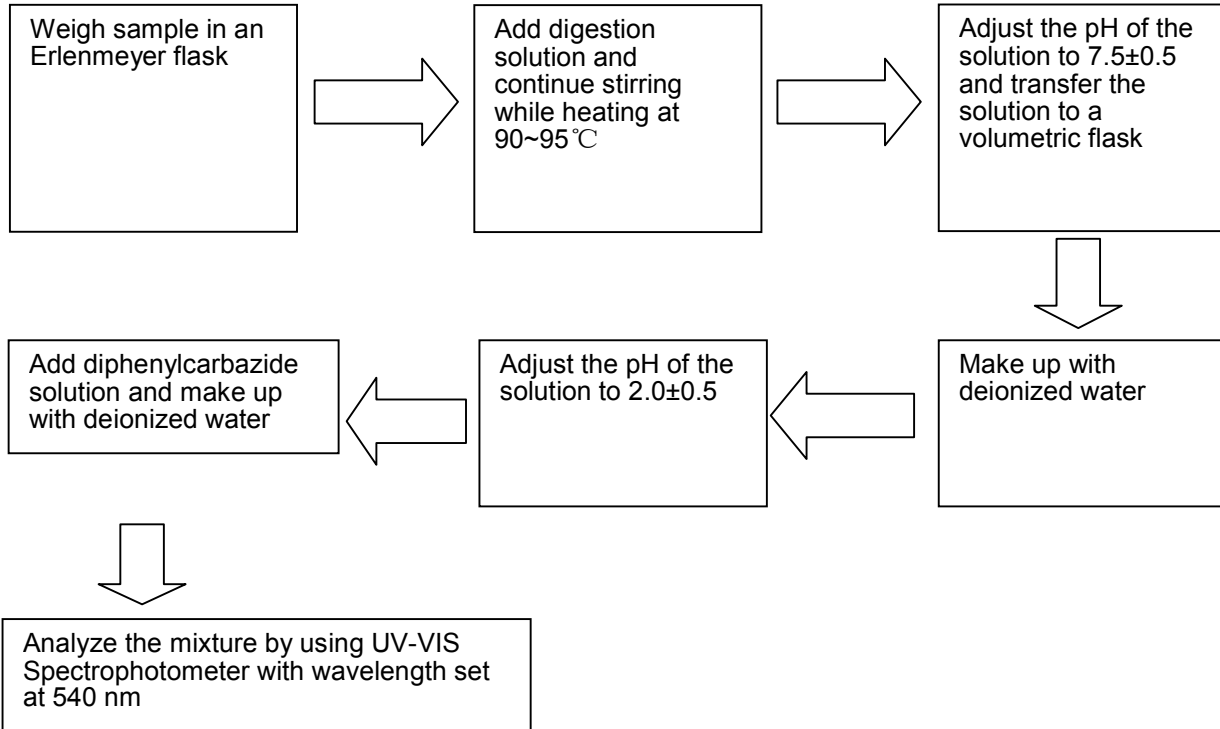

2. Test for Hg Content

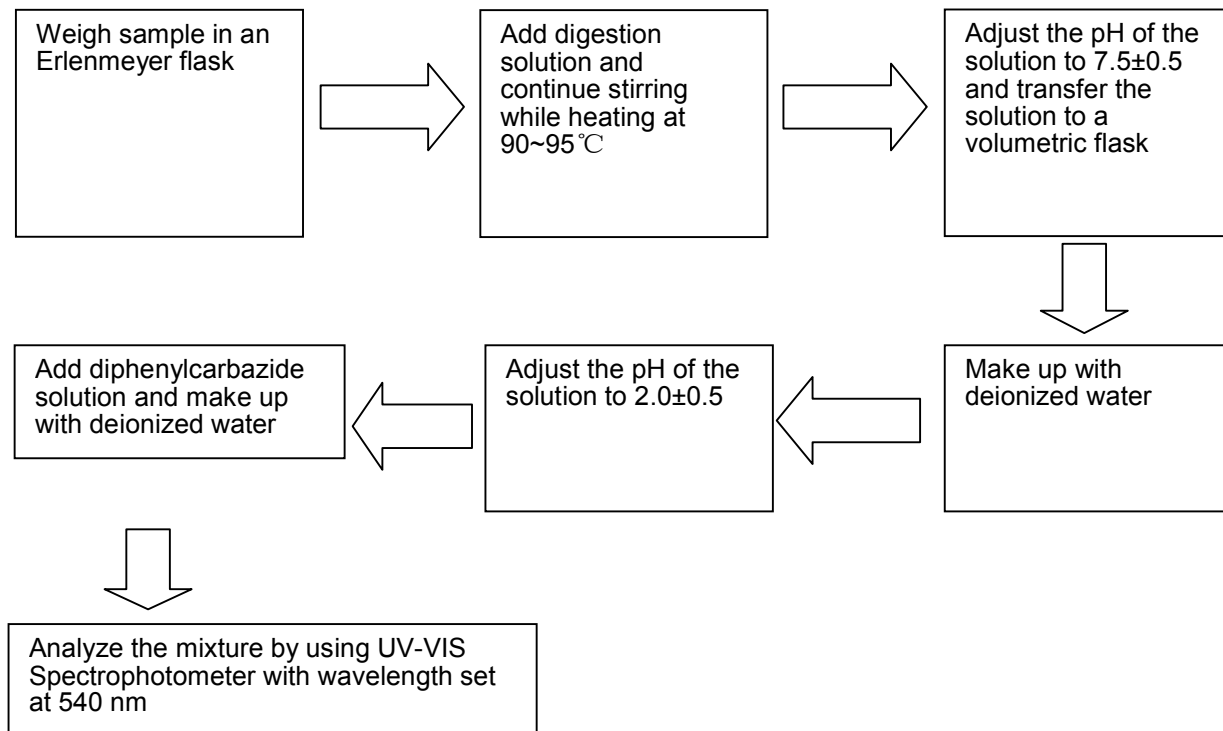

2. Test for Hg Content

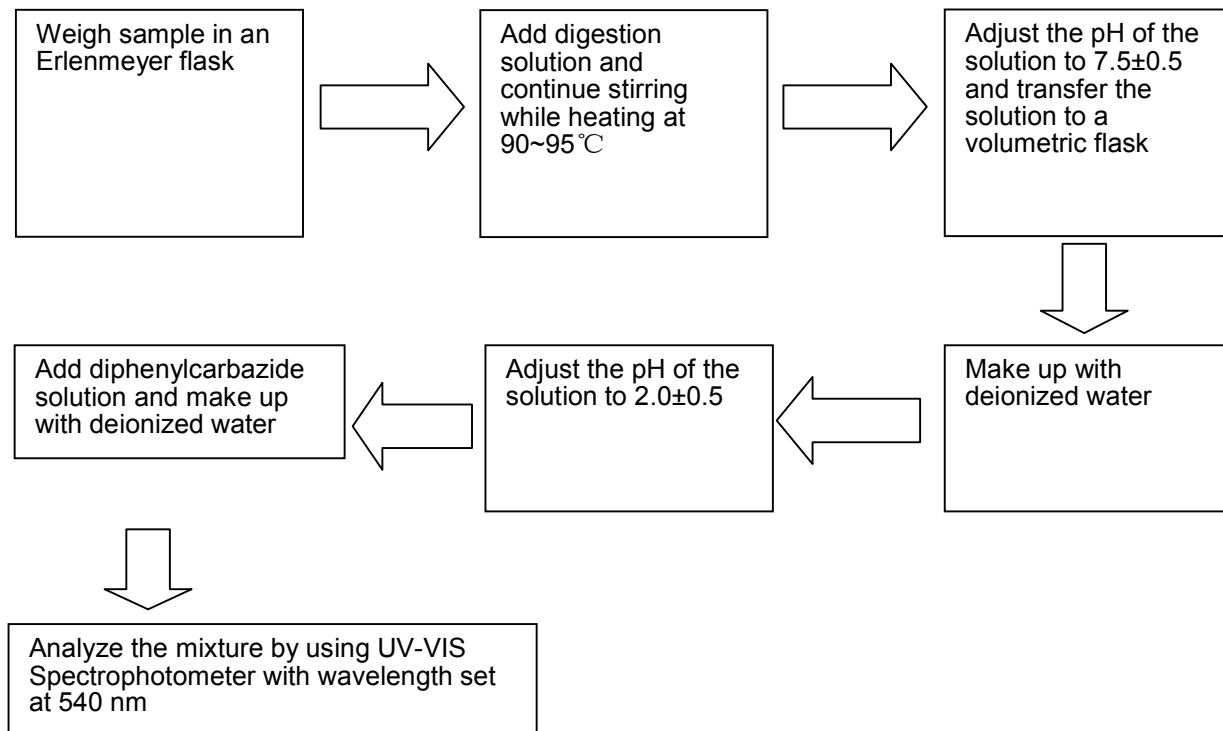

2. Test for Hg Content

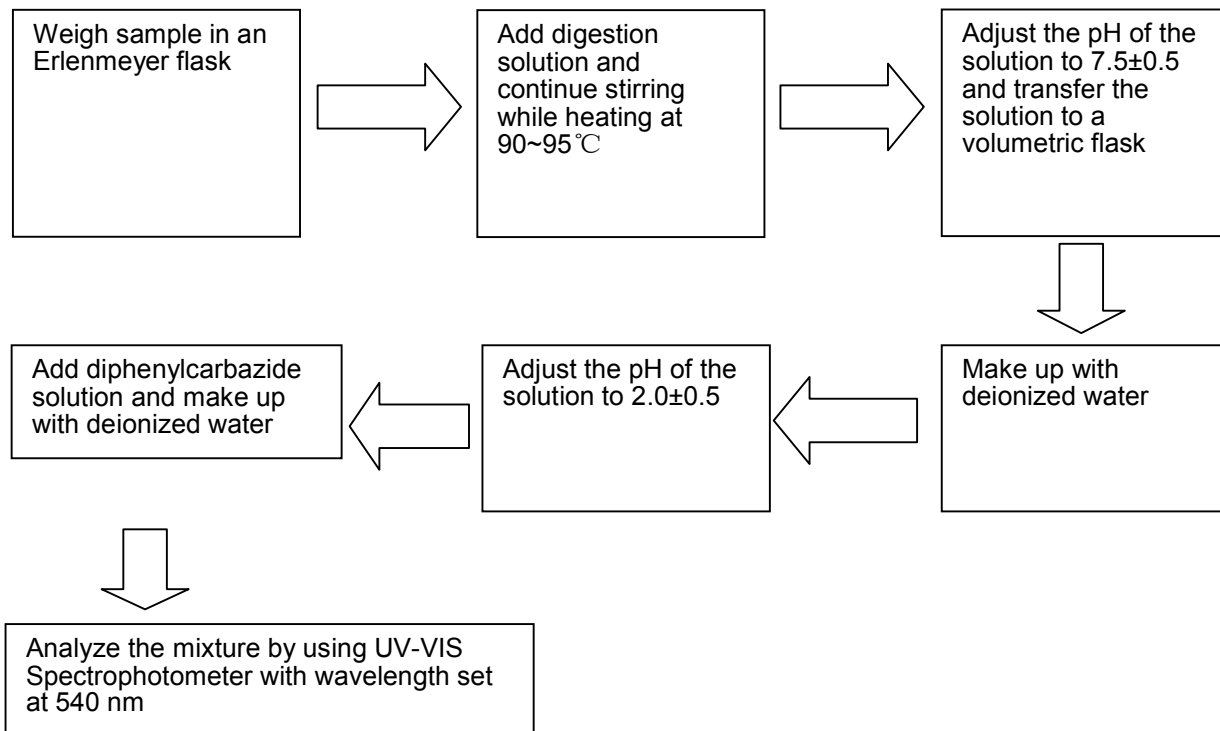

2. Test for Hg Content

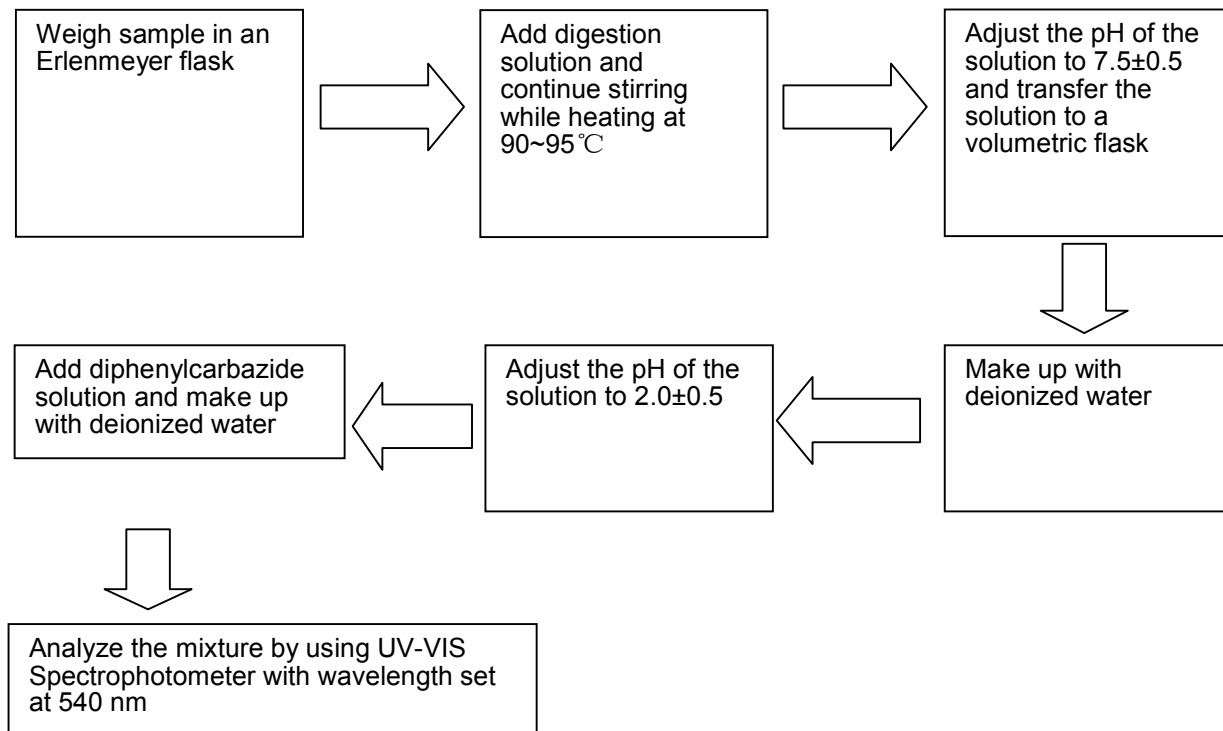

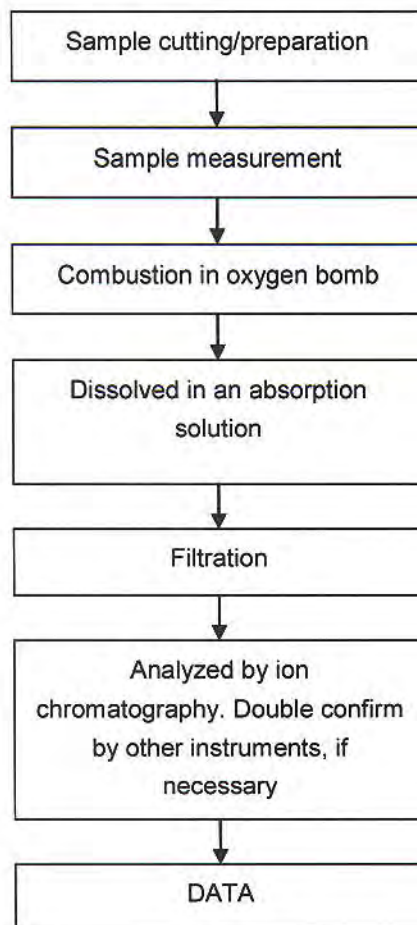

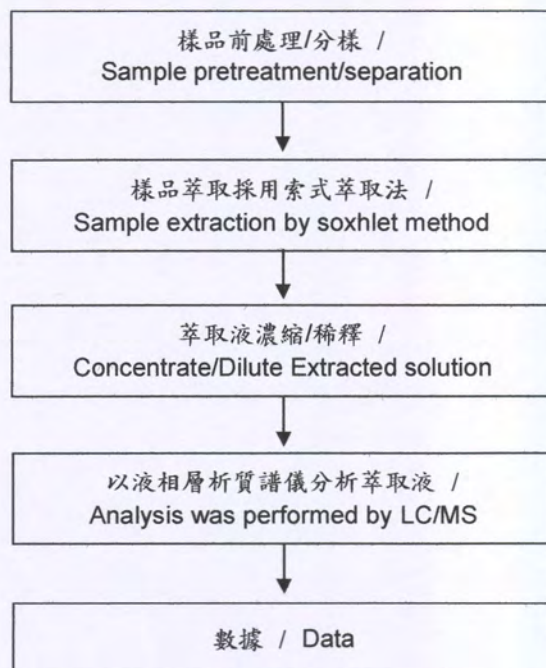

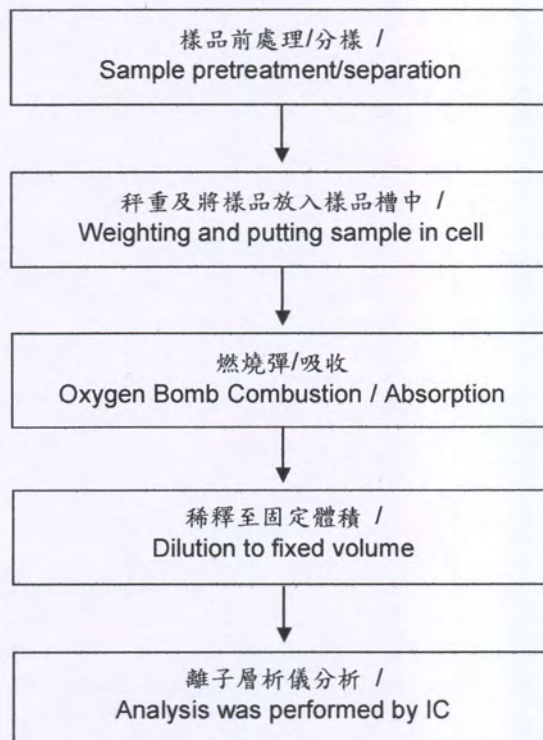
