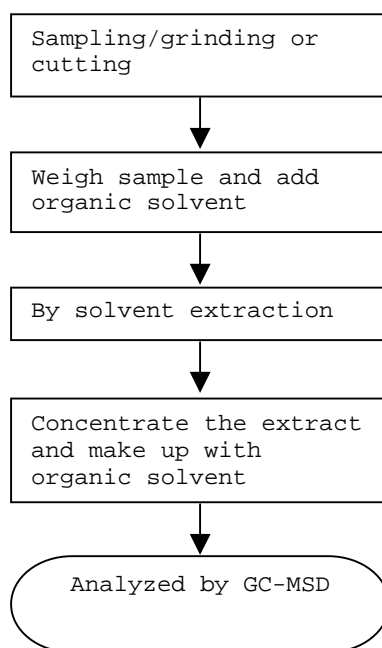

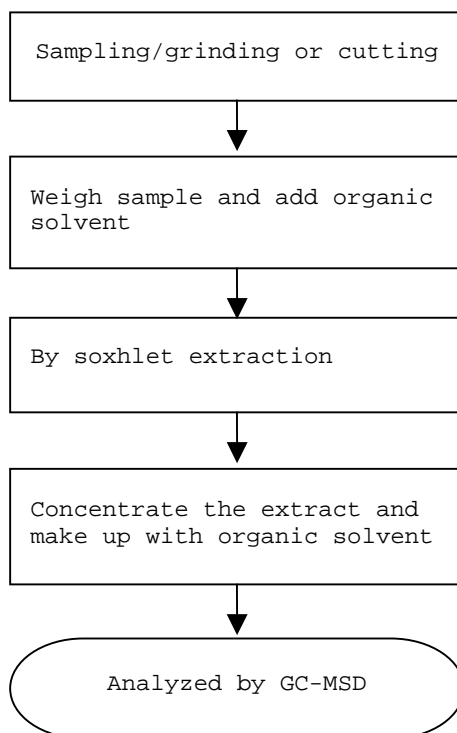

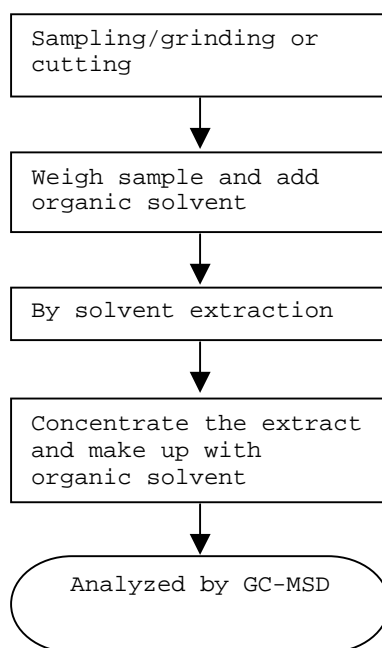
Test for Halogen Content

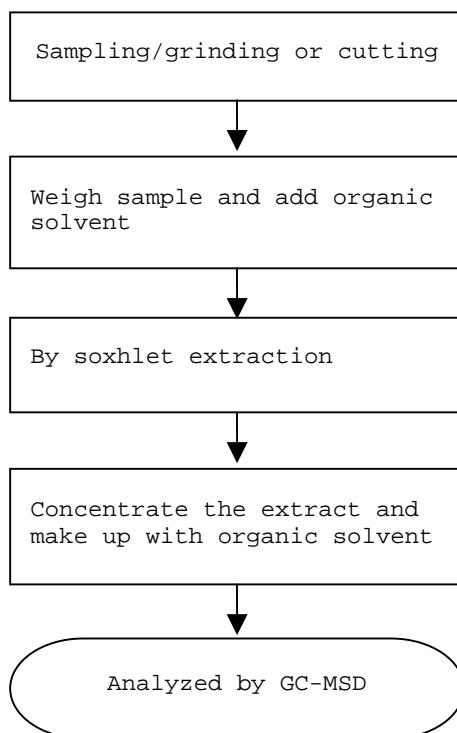

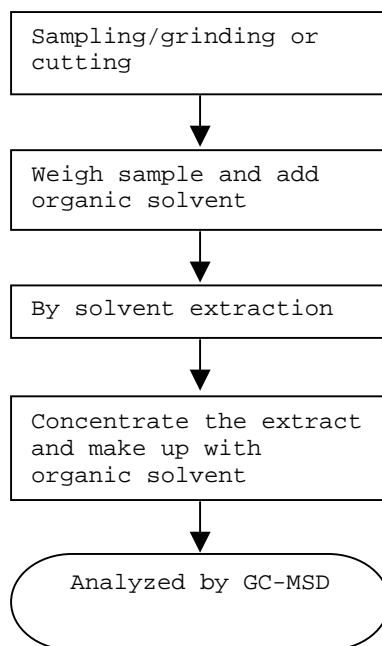

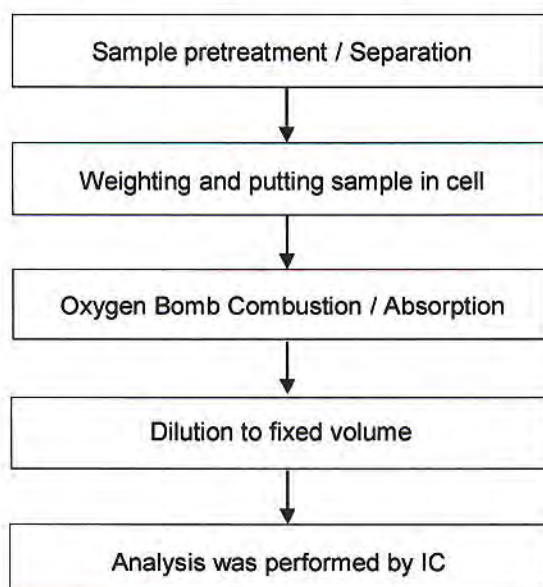
