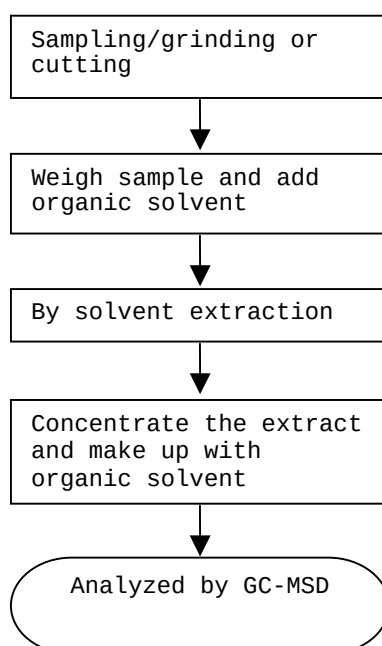

(IV) Measurement Flowchart:

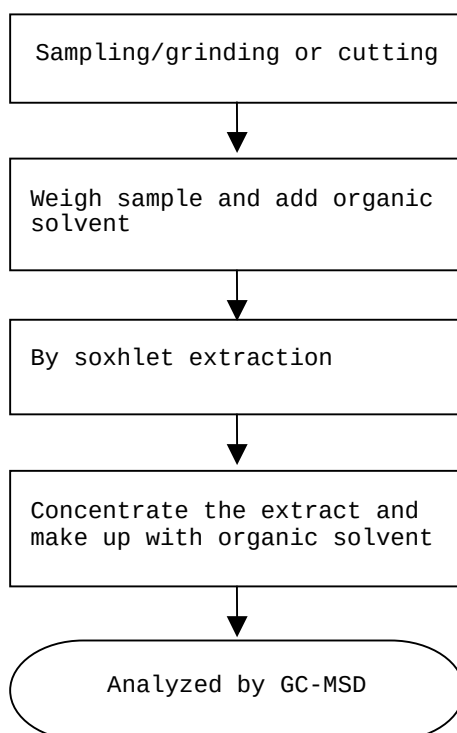
Test For Phthalates Contents

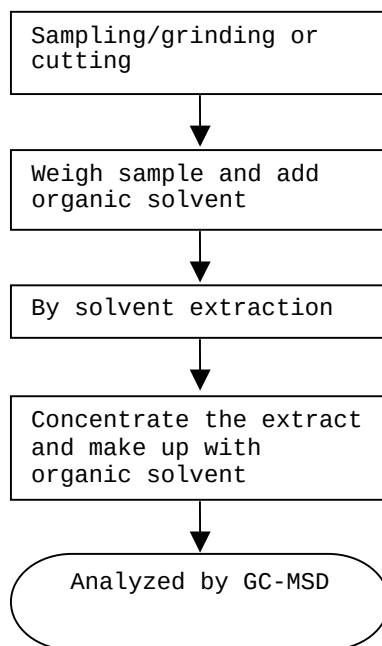

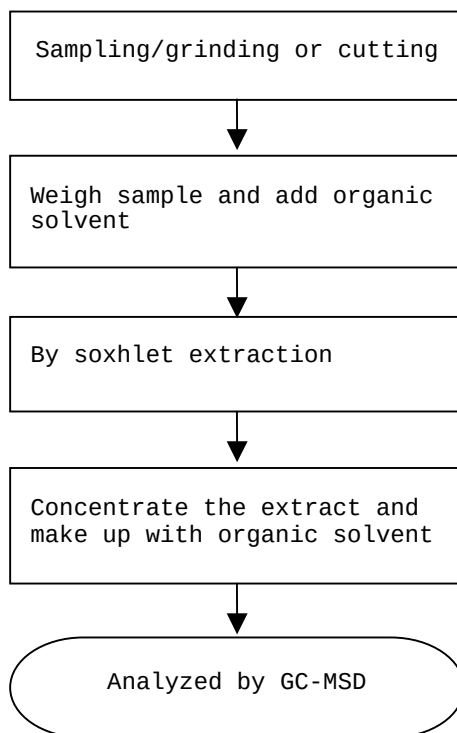

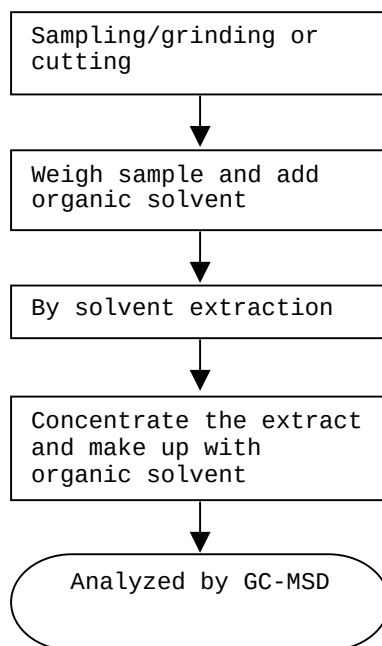

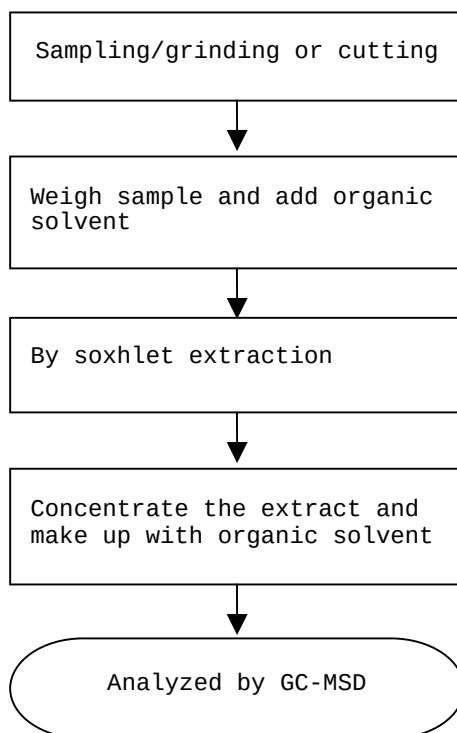

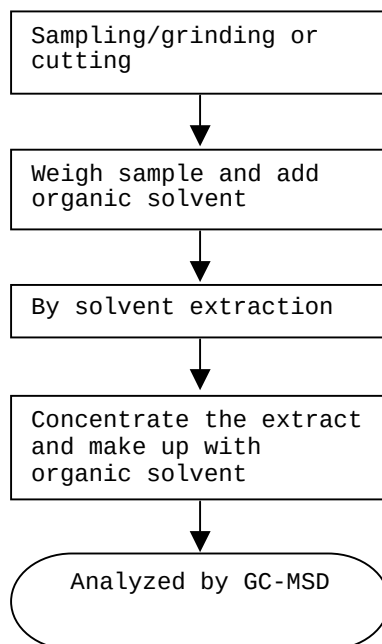

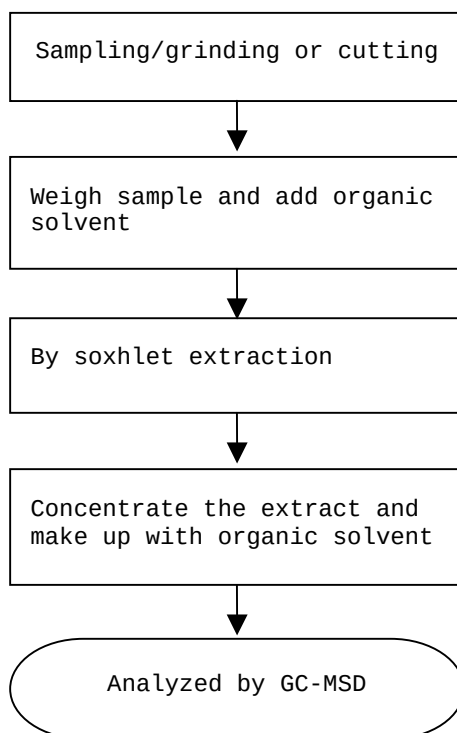
